By signing the Rescue Contract, I, the undersigned New Owner, understand, acknowledge and agree to the terms outlined below:

1. I understand and acknowledge that at the time of possession of this Hound, the Irish Wolfhound Club of Canada ("IWCC") Rescue Committee will provide me with any/all veterinary records that are available to them at the time regarding this Hound, such as:
 - Wellness check by licensed Veterinarian
 - Immunization records
 - Test(s) and procedures known to date.
 - Microchip number
2. I understand and acknowledge that IWCC Rescue Committee has requested as much information as possible from the surrendering party related to the issues leading to the rehoming of this Hound.

3. I understand and acknowledge that IWCC Rescue Committee has disclosed all information provided to them regarding this Hound, and all observations made while this Hound has been in their care, and that this information may not be complete. I further acknowledge and accept the full disclosure provided by IWCC Rescue Committee regarding the special needs in placement of this Hound.
4. I understand and acknowledge the challenges associated with fostering/adopting a rescue or rehomed Hound and will accept the financial and physical responsibility of this Hound once I am in possession of the same.
5. In exchange for possession of this Hound and the full disclosure provided by IWCC contemplated in clauses 1-3 herein, I do hereby for myself, my agents, heirs, and assigns, forever release IWCC, its respective directors, officers, employees, successors, heirs, executors, and assigns (collectively, the "IWCC Parties") from any actions, causes of actions, claims and demands for damages, including any indemnity, costs, interest, loss or injury of every nature and kind whatsoever and howsoever arising, which I may have had, have or hereinafter have against the IWCC Parties, including but without limiting the generality of the foregoing, and matter or cause arising from, or related to or as a result of my possession of the Hound, the Hound's mental and physical health, the Hound's general compatibility with myself and third parties, and any other deficiencies.
6. I agree to indemnify IWCC, its affiliates and each of their respective directors, officers, employees, agents and representatives, and hold each of them harmless, from and against any and all claims, losses, expenses, liabilities, demands, obligations, costs, legal fees on a solicitor and own client (full indemnity) basis, and damages of every kind and character (including, without limitation, any injury to or death of any person and loss of property by whomever owned and without regard to the cause or causes thereof or the negligence or strict liability of any person or party) arising out of or connected with this Hound and his/her interactions with myself or third parties.
7. If this Hound is not spayed/neutered before possession, I agree to have this Hound spayed/neutered once he/she has turned two (2) years old. Upon submission of the spay/neuter certificate to the Club Treasurer, a reimbursement of two hundred (\$200.00) dollars will be provided to me.
8. I am aware of the IWCC's offer of free membership for new members for the first year of possession and the need to complete the Membership Form to take advantage of this offer.
9. I understand and acknowledge that the Rescue Contract will be securely stored on the IWCC's password protected iCloud. I further understand and acknowledge that IWCC's copies of this Rescue Contract will be destroyed after ten (10) years and that no personal information will be shared with third parties without my consent.

10. This Rescue Contract represents the entire agreement between the me and IWCC respecting the subject matter hereof and supersedes all prior negotiations, representations, or agreements, either written or oral.
11. If any provision of this Rescue Contract is held to be unenforceable, invalid or illegal by any court of competent jurisdiction, such unenforceable, invalid or illegal provision shall not affect the remainder of this Rescue Contract.
12. This Rescue Contract may be executed and delivered in counterpart, including execution and delivery by DocuSign or in PDF format by e-mail, each of which when so executed and delivered shall be deemed to be an original, and such counterparts shall constitute on and the same Rescue Contract and shall be deemed to be and constitute a properly executed and delivered document and further, notwithstanding the date of execution of such counterparts, shall be deemed to bear the date as of the document so executed.
